Customers that are provided with a level of service greater than the minimum level of service as shown above for garbage collection services, shall be charged the rates shown in Table 2a and Table 3 for their specific level of service. - The rates in Table 1 Residential (one to four dwelling units) include collection for all three (3) curbside carts including: garbage cart(s), one (1) - 64-gallon recycling cart, and one (1) - 96-gallon compost cart. The rate for curbside services is based upon the size of the garbage cart. Additional residential recycling or compost carts will be subject to the service fees as listed on the County website at <https://www.smcsustainability.org/waste-reduction/curbside-collection/>.
- Table 1., Minimum Level of Service Rates for 1- 4 residential dwelling units are billed on the property tax bill.
- Carts that are not located within five (5) feet of the road right-of-way will incur additional service charges by Recology San Mateo County based upon the distance of the cart to the right-of-way in the road as listed in Exhibit B (Unscheduled Service Fees) found at <https://www.smcsustainability.org/waste-reduction/curbside-collection/>

- Commercial (five (5) or more residential dwellings or commercial), Recology curbside commercial collection services is within 51 feet of the right-of-way of the road. Bins or Carts located 51 feet or more from the road right-of-way, will incur additional service charges by Recology, based on the distance of servicing the Carts or Bins to the right-of-way.
- Residential (one (1)-four (4) residential dwellings) bins or carts, that are not located within five (5) feet of the right-of-way of the road, will incur additional service charges by Recology San Mateo County, based upon the distance of the bin or cart to the right-of-way as listed in the Exhibit B (Unscheduled Service Fees) found at <https://www.smcsustainability.org/waste-reduction/curbside-collection/>.

Notice of Proposed Increase in Garbage and Recyclables Collection Service Rates

County Service Area No. 8
(North Fair Oaks area)
effective January 1, 2025

This notice is to advise property owners of the County of San Mateo Board of Supervisors' (Board) proceedings to set rates for garbage and recyclables collection services in County Service Area No. 8 (North Fair Oaks area). Adoption of the rates will result in property related charges, and this notice is, therefore, given in accordance with Proposition 218 and Article XIID of the California Constitution.

Garbage and Recyclables Collection Service in North Fair Oaks

Garbage and recyclables collection services to properties in County Service Area No. 8 (North Fair Oaks area) are provided through a Franchise Agreement between the County of San Mateo and Recology San Mateo County (Recology). The County generates the revenue to pay the collection service provider for the minimum level of service required by the County Ordinance Codes by charging each affected parcel (any parcel containing a dwelling unit) a minimum charge for garbage and recyclables collection on their property tax bill. Commercial parcels and any additional services above the minimum charge on the property tax bill are billed directly by Recology. The County Ordinance Code ("Title 4, Sanitation and Health, Chapter 4.04 Solid Waste Collection, Transport, Storage, and Disposal") defines the Minimum Levels of Service for County Service Area No. 8 parcels as:

- **Residential parcels** one (1)-64-gallon cart or two (2)-32-gallon carts per dwelling unit.
- **Apartment House parcels** (more than four dwelling units): one (1)-32-gallon cart per dwelling unit.
- **Mixed Residential/Commercial and Industrial parcels:** one (1)-32-gallon cart per residential dwelling unit and one (1)-32-gallon cart per business.
- **Commercial parcels:** one (1)-32-gallon cart per business.

ReThinkWaste

ReThinkWaste, also known as South Bay Waste Management Authority (SBWMA) is a joint powers authority formed by eleven local government jurisdictions. This authority owns and manages the Shoreway Environmental Center and provides oversight and support of service providers that collect, process, and dispose of waste materials. Recology San Mateo County (Recology) is the current franchise holder and provides solid waste collection services to County Service Area No. 8 (CSA-8) and the Unincorporated Franchised Area (CFA) within the SBWMA service area (Burlingame to Menlo Park). Proposed Rate Increase

The adoption of the annual garbage and recyclables collection rates for CSA-8 (North Fair Oaks) follows a Proposition 218 rate-setting process. This includes setting a hearing date, holding a public hearing, and adopting the final rates for the calendar year. The rates specified in this notice have been calculated based on the cost and revenue data published by the SBWMA in the "SBWMA Final Report Reviewing-The 2025 Recology San Mateo County Compensation Application" dated September 19, 2024 (referred to as SBWMA 2025 Rate Report). These rates have been modified, as deemed necessary, to meet the financial requirements for providing garbage and recyclables collection services for Calendar Year 2025 in CSA-8. The final report was adopted by the SBWMA Board on September 26, 2024, and can be viewed by visiting the rethinkwaste website at <https://rethinkwaste.org/wp-content/uploads/2024/09/SBWMA-BOD-PACKET-0926204.pdf>

The County sets the rates for solid waste collection to meet the projected SBWMA costs for the service area. The Residential and commonly used Commercial bin or cart proposed rates for calendar year (CY) 2025 are listed in this notice. For all other proposed bin or cart rates, and other unscheduled services, please visit our website at <https://www.smcsustainability.org/waste-reduction/curbside-collection/>. The proposed rate for two 32-gallon garbage carts or one 64-gallon garbage cart for one to four residential dwelling units will increase by \$4.56 per month, representing an increase in monthly charges from \$41.46 to \$46.02. For dwellings that contain over four units, or considered a mixed-use parcel, the proposed rate increase for 32-gallon garbage carts is \$4.56 per month (an increase from \$41.46 to \$46.02 per month). The recommended rates will continue to reflect a 5 percent franchise fee that will be paid to the County from Recology to administer these programs.

The garbage services at your home or business include two cost components: (1) processing and disposal at the Shoreway Environmental Center; and (2) the Recology curbside collection services. The SBWMA 2025 Rate Report indicates a 11 percent rate increase is needed to cover both cost components in CSA-8. In alignment with the rate reducing strategies approved last year, the proposed 11 percent increase for CY 2025 includes the Recology Carry Forward costs that were deferred from 2024. The proposed rate increase percentage also includes the remaining cost increase from CY 2024 and will conclude the two-year phased approach.

The recommended proposed rate increase of 11 percent would be effective on January 1, 2025. The charges based on the rates will appear on the property owner's tax bill for FY 2025-26 for all parcels with dwelling units, under County Ordinance Codes 4.04.200 and 4.04.220. Recology will bill for any additional elective services. Commercial parcels without dwelling units will continue to be billed by Recology directly for all services.

Unscheduled Services terms are part of the Amended and Restated Franchise Agreement, and they are considered additional elective services that are specifically requested and paid for by the ratepayers. Any Unscheduled Services requested by the customer, Recology will bill directly to the customer, and these service rates are effective January 1, 2025. These Unscheduled Services fees are not property related fees and, therefore, not subject to the Proposition 218 rate setting requirements.

What Do The Proposed Garbage and Recyclables Rates Pay For?

- **Residential weekly curbside collection for garbage, recycling and organics**
- **Commercial weekly collection for garbage and recycling**
- **Free used motor oil and oil filter collection for residents**
- **Two free "On-Call" bulky item pick-ups**
This service is a scheduled service (Feb-Dec).
- **Curbside cell phone and battery collection**
Reminder: Batteries should not be placed inside your cart. Place on top of black cart into a clear plastic bag.
- **Holiday tree recycling during the month of January**
- **Free mattress recycling** at Shoreway Environmental Center (residents only)
- **Free electronics and small appliance recycling** at Shoreway Environmental Center
- **Free confidential document shredding events**
- **Energy-efficient, cleaner emission garbage and recycling collection trucks**
- **Operation of the Shoreway Environmental Center** for solid waste and recycling processing.



Public Hearing

The Board of Supervisors has scheduled a Public Hearing on Tuesday, January 14, 2025, at 9:30 a.m. to consider adopting a resolution for the proposed garbage and recyclables collection service rates for County Service Area No. 8 (North Fair Oaks area). The proposed rates are partially listed in this notice and on the Board meeting agenda website. Pursuant to Government Code Section 54953(e), the board meeting will be a hybrid meeting, open to the public for participation both in-person and online via Zoom. Anyone wishing to be heard on this matter may appear in person or via Zoom, or may submit a written statement to the Clerk of the Board. The Zoom link can be found at <https://sanmateocounty.legistar.com/Calendar.aspx> under the January 14, 2025 date and will be published on Friday, January 10, 2025. Written statements may be submitted to the Clerk of the Board via mail (Clerk of the Board, 5th Floor, 500 County Center, Redwood City, CA 94063) or email (boardfeedback@smcgov.org).

Any property owner in County Service Area No. 8 may file a written protest against the proposed rate increases. The Board will consider all input, but State law provides that only written protests from property owners may be counted to determine if a majority protest to the proposed increase exists. In order to be counted, written protests must be received by the Clerk of the Board no later than the closing of the Public Hearing specified above, and must include: the property owner's name, property service address, assessor's parcel number (tax assessor's parcel number), and the property owner's signature. Written protests may be hand delivered or mailed to the Clerk of the Board at 500 County Center, Redwood City, California 94063. No more than one protest per parcel may be submitted.

If a majority protest exists, the Board cannot impose the increased rates. If, at the conclusion of the Public Hearing, a majority protest of property owners does not exist, the Board will consider adoption of the proposed rates.
